ACCEPTING DEDICATION OF A CERTAIN STREET, SIDEWALK AND PORTION OF WATERLINE

WHEREAS, each of those conditions precedent as set forth in Section 2 of Resolution No. 953 are determined by this Council to have been satisfactorily fulfilled;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILMINGTON, STATE OF OHIO:

Section 1. That Carrie Drive, intersecting with Rombach Avenue and running along the west margin of the Wal-Mart Development area as identified in the Dedication Plat, Carrie Drive and Utility Easements prepared by CLINCO Engineers and Surveyors, dated May, 1990, including the sidewalk adjacent thereto on the west, rights of way, and that portion of the water line running under said street and sidewalk rights of way, are hereby accepted for public use. Storm and Sanitary Sewers identified on said Plat are not hereby accepted.

Section 2. That this ordinance shall be in full force and effect from and after the earliest period allowed by law.

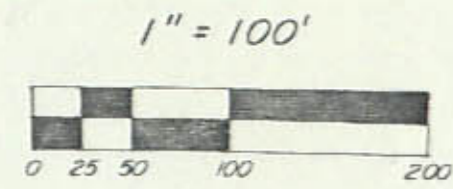

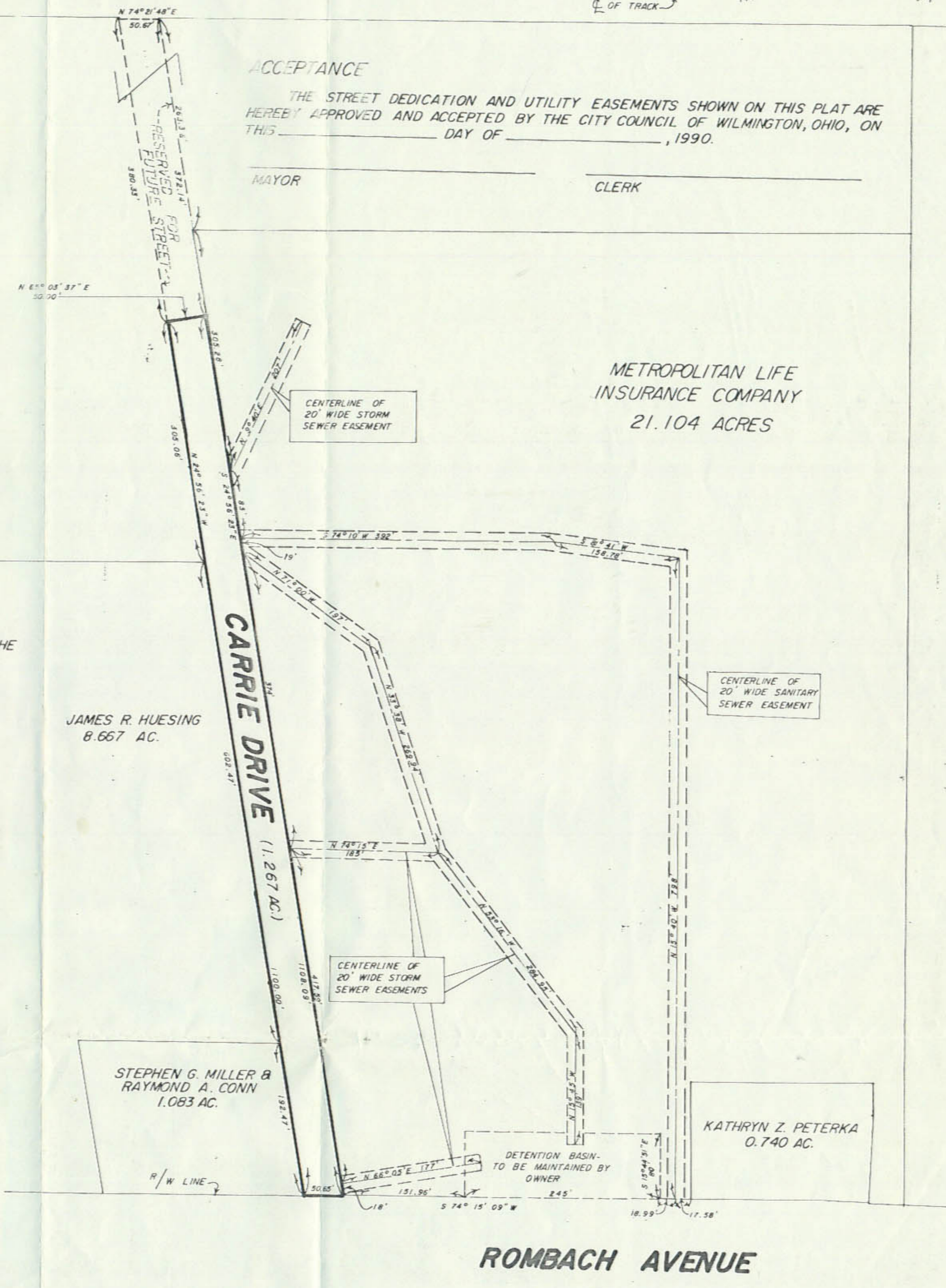
