

ORDINANCE NO. 3705

VACATING ALLEY

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILMINGTON, STATE OF OHIO:

Section 1. Council finds that a Petition to Vacate and close the 16' alley between Lots 141 and 142 on Kentucky Avenue in E. R. Mills Grandview Addition was presented to the Planning Commission by Jeffrey A. Goldie and Debra A. Goldie. Said Planning Commission has recommended that the 16' alley be vacated:

Section 2. Council held a public hearing on said alley vacating on September 5, 1996.

Section 3. Council finds that there is good cause for vacating a said alley, that it will not be detrimental to the general interest, and that the said vacation of the alley should occur.

Section 4. Said alley is hereby vacated.

Section 5. The Service Director is hereby instructed to notify the County Tax Map Office of said alley vacation by sending that Office a copy of this ordinance.

Section 6. The Clerk of Council is directed to notify the Auditor of Clinton County of the vacation, by sending her a copy of this ordinance.

Section 7. That this ordinance shall be in full force and effect from and after the earliest period allowed by law.

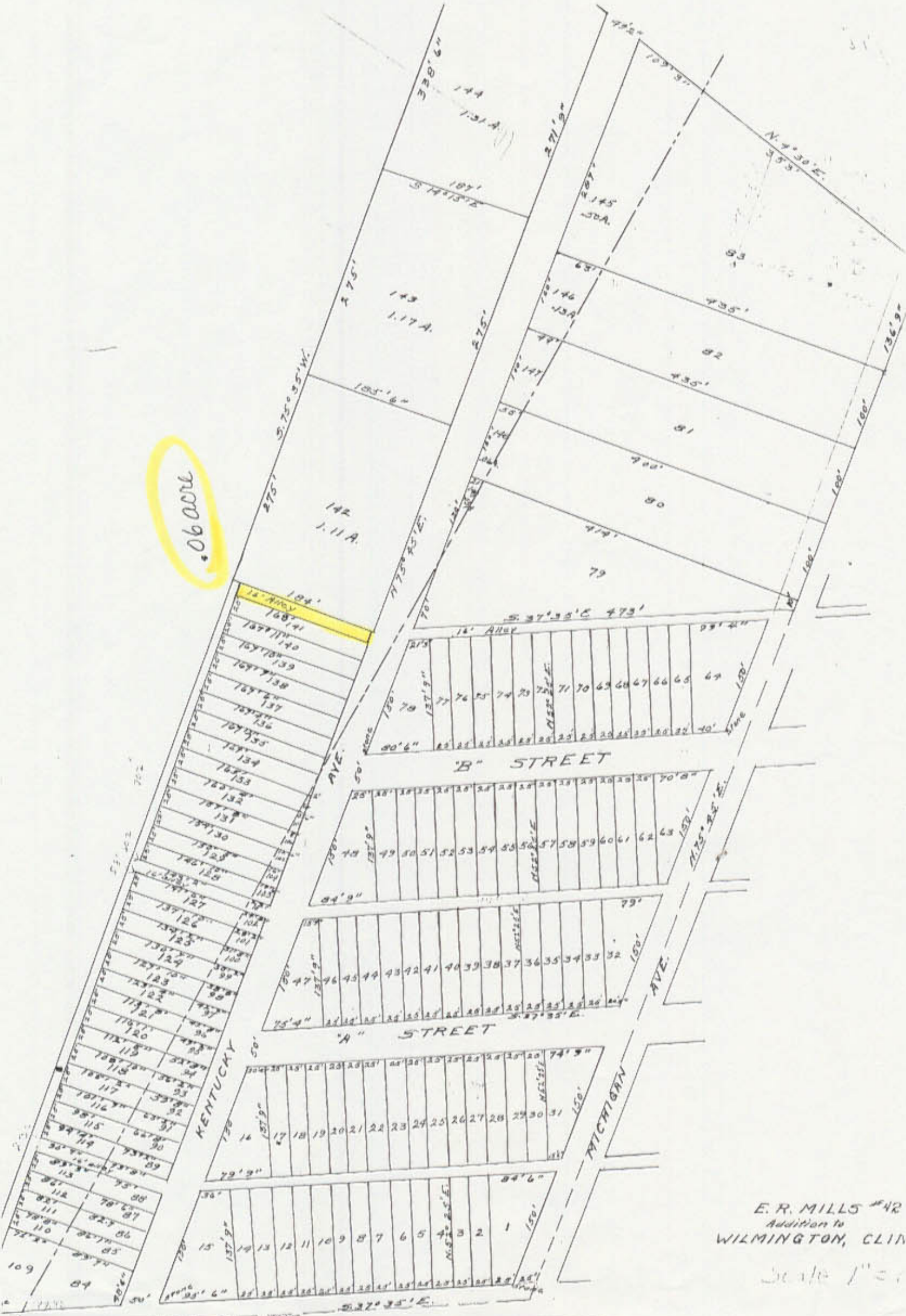

Section 2. That the certain 14-inch water main, 24-inch storm sewer main and 8-inch sanitary sewer main and appurtenances installed within the described dedicated area, and the existing 20-foot utility easement and/or existing U.S. Route 68 highway easement as set forth on attached "Exhibit B" and "Exhibit C" are hereby accepted for public use.

Section 3. That this ordinance shall take effect and be in full force from and after the earliest period allowed by law.

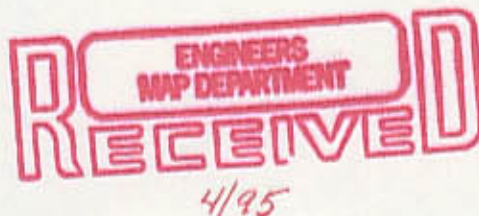

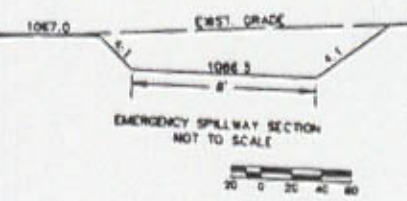

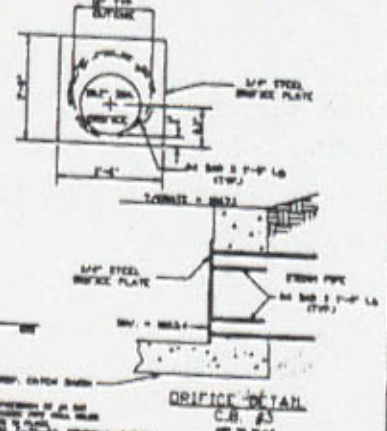
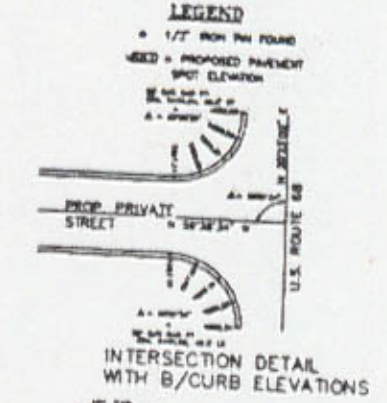
