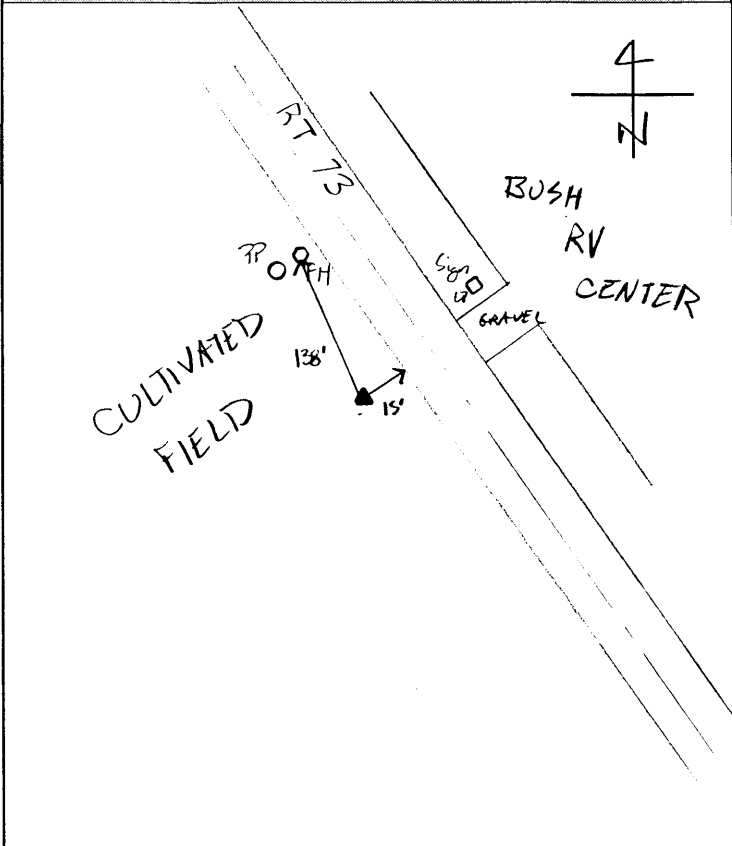

STATION LOCATION



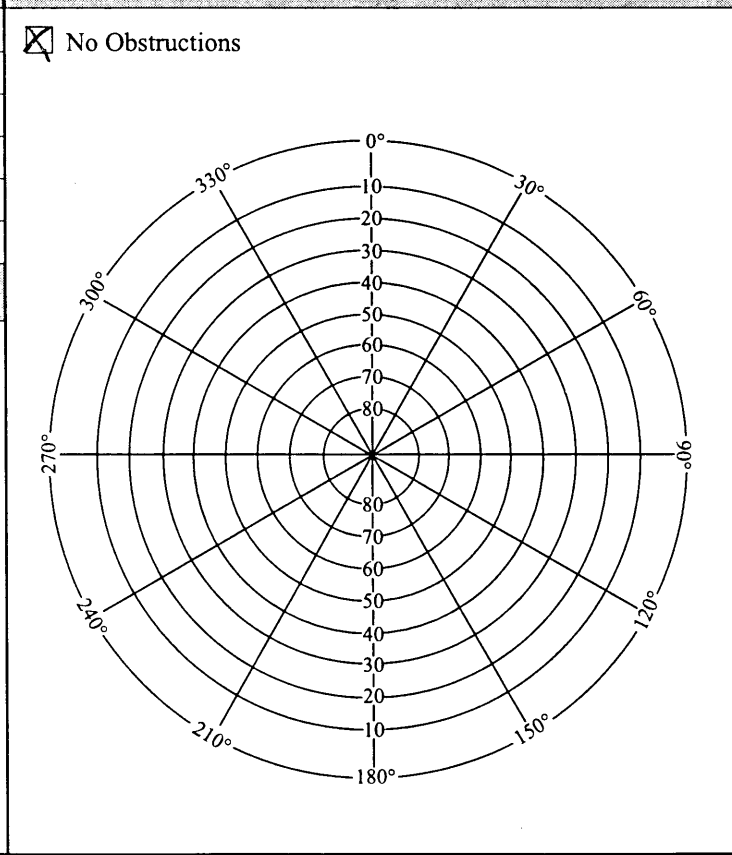

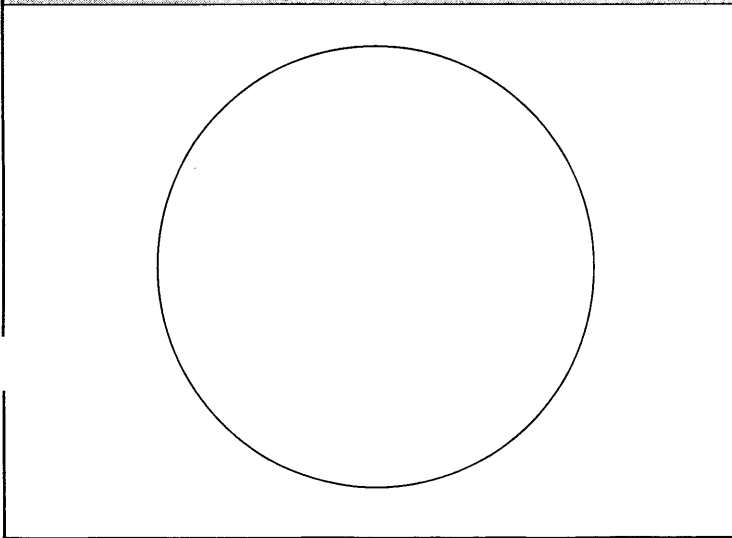

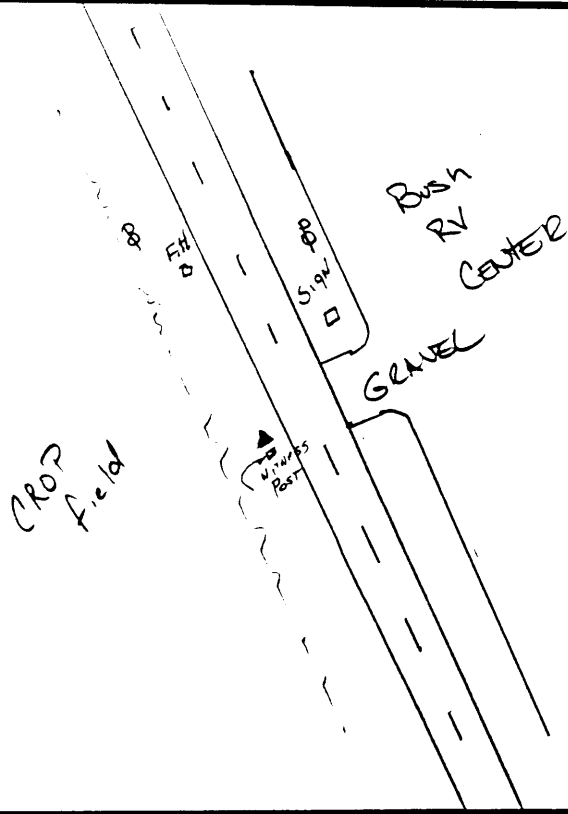
