

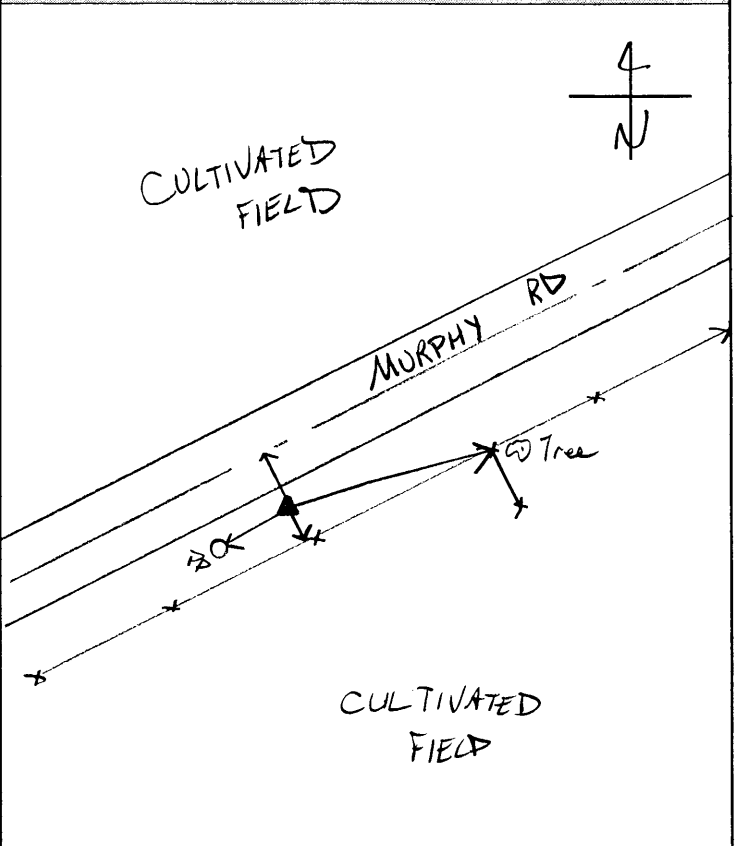

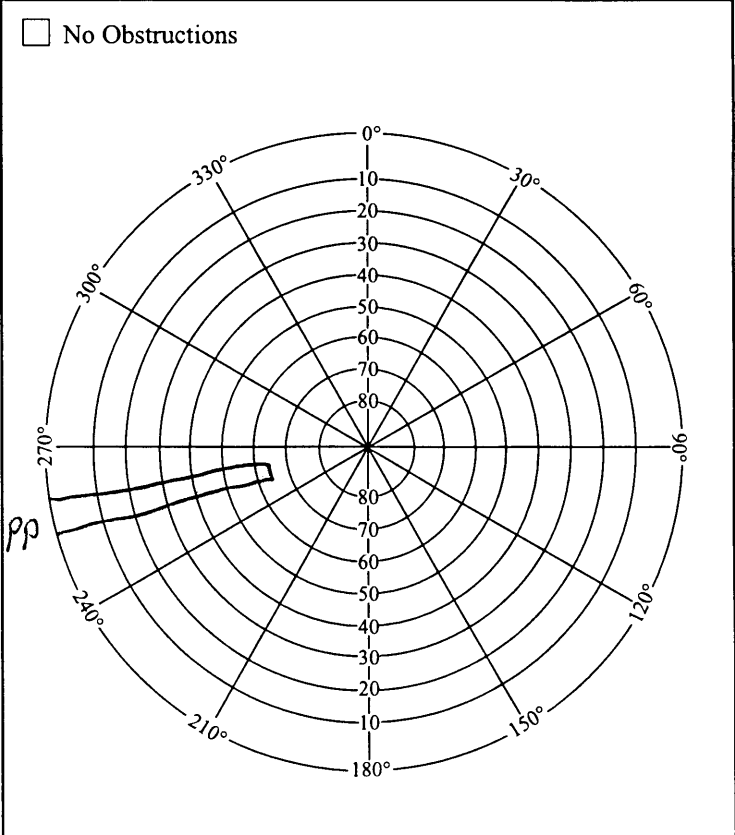


## TO-REACH DIRECTIONS

 1.0 mile to SR 73 (13)

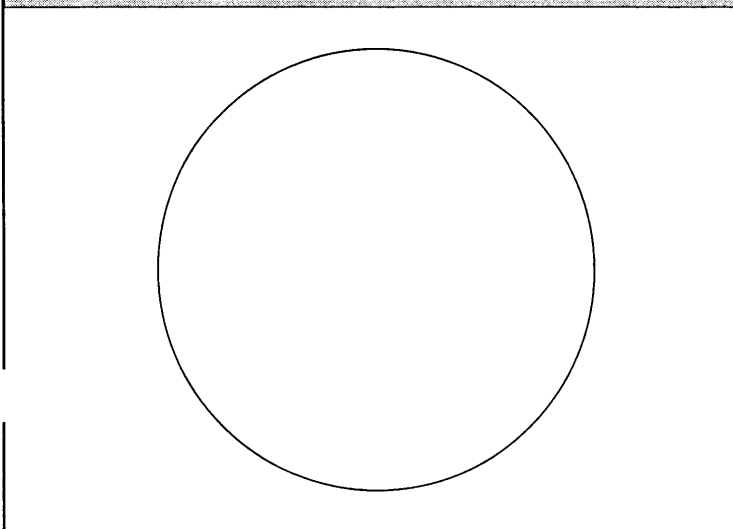
## VISIBILITY DIAGRAM

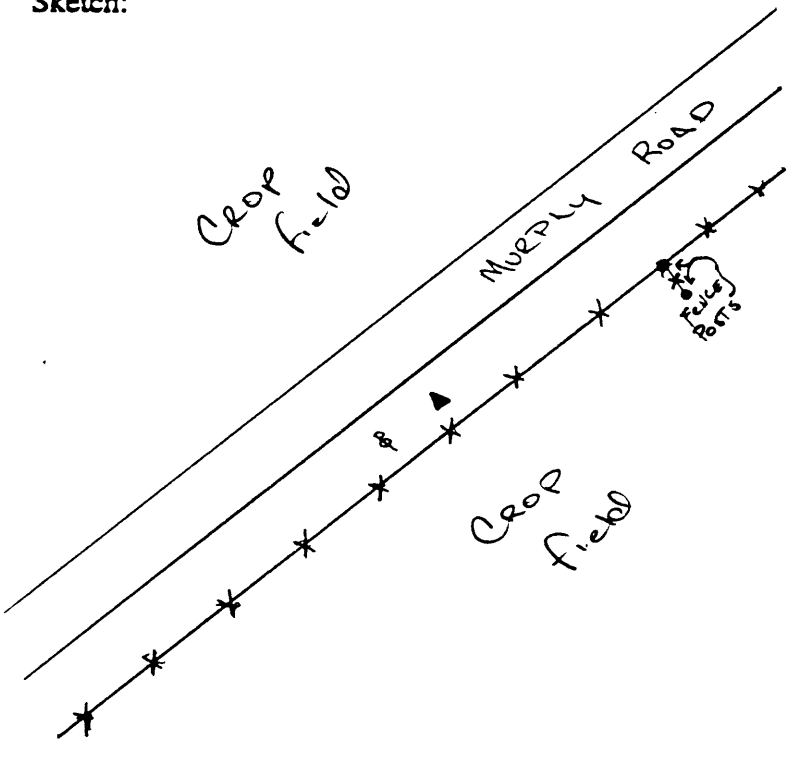

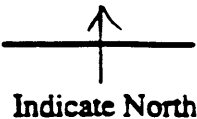
