All whom it may concern will take notice that a petition was filed in the Office of the Commissioners of Clinton County, Ohio on the 4th day of December 1866 praying for the annexation of certain territory surrounding and adjacent to the present Corporate limits of the Incorporated Village of Wilmington as follows Beginning in the center of the Kenia road and N E corner of Lewis Walkus land thence in a straight line to a stone in the center of the Port William road where a stake in the center of said road ^{and} in ^{the} line of Samuel Smith's ^{land} bears S 2 1/2 degrees E 24 1/2 poles; thence in a straight line to a stone in the center of the Prairie Road opposite Sarah Howarth's barn; thence on a straight line passing the N E corner of W^m Applegate's land and with his old line to the center of the turnpike road leading to Sabinia thence with center of said road to the N W corner of John Dillons land; thence with said Dillon's west line to a stone corner to said Dillon and in the line of Jacob M. Patton's land; thence with said Patton's line to his N E corner; thence with his line S 42 deg 55 minutes W 40.22 poles to another of his corners and in the line of Stephens survey No 2693 thence with another of his lines S 47 degrees 05 sec E 60.70 poles to a stone corner to said Patton; thence with another of his lines S 2 1/4 deg W 33 1/10 poles to a stone corner to said Patton; thence with another of his lines N 88 deg 44 3/4 poles to a stone corner to said Patton thence with another of his lines S 2 3/4 degrees W 21 92/100 poles to a stone corner to said Patton in James Fifes line; thence with said Fife's N line N 87 deg 57 min W to a stone corner corner to said Fife and in the E line of J Pacey's Survey No 1067 thence with said survey line to a stone corner to said survey; thence W with the S line of said survey to the N W corner of Jonathan Dean sr and Jonathan Dean jr. land thence with their W line to Lyth's creek; thence down said creek with the meanders thereof to the center of the Cuba road and corner to a tract of land belonging to Rachel Walkus and others thence with their S line to a stone corner to said land; thence with their W line to said creek; thence down said creek following the meanders thereof to the S line of said Pacey's survey; thence W with said survey line to a stone in said creek line S E corner to Lee Kelly land thence in a straight line to a stone S E corner to Nancy Lair's lot thence with her S line to a stone corner to said lot; thence with the W line of said Lair Eno Baker and Elizabeth Owens to a stone N W corner to said Owens; thence with her north line passing her corner and with the line of J M Richardson to a stone corner to said Richardson and in the line of W^m Hale land thence with his W line to his N W corner thence with his N line to his N E corner and in the line of ^{the} Strickle's land; thence with the west ^W line of the said Strickle land to the N W corner thereof; thence with the N line of said land to a stone corner to said land and corner to W Babb's land thence with his W line to a stone corner to said Babb and corner to L P Walker
