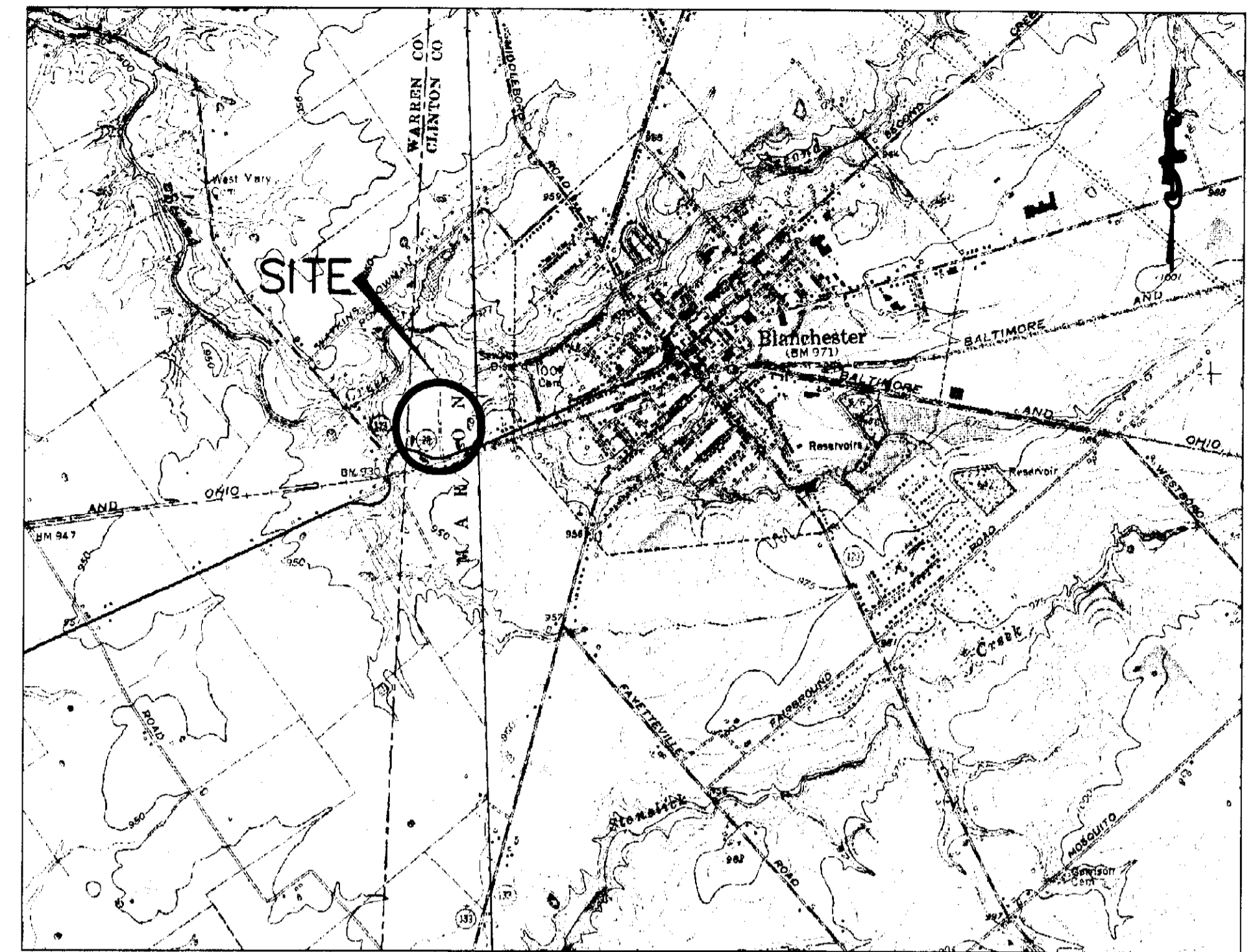

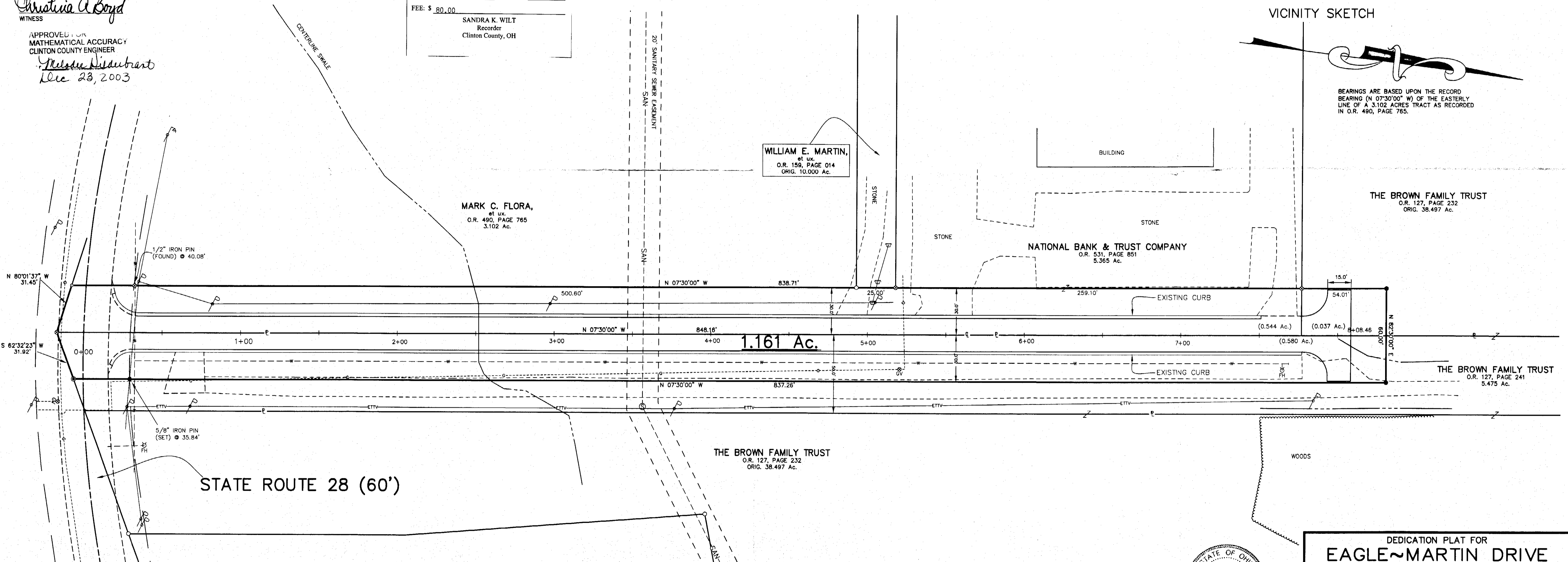

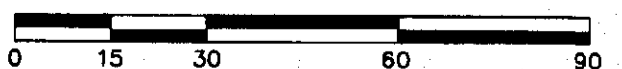
VICINITY SKETCH

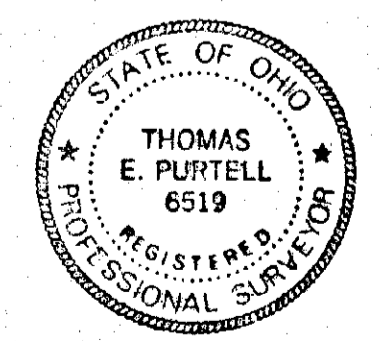
