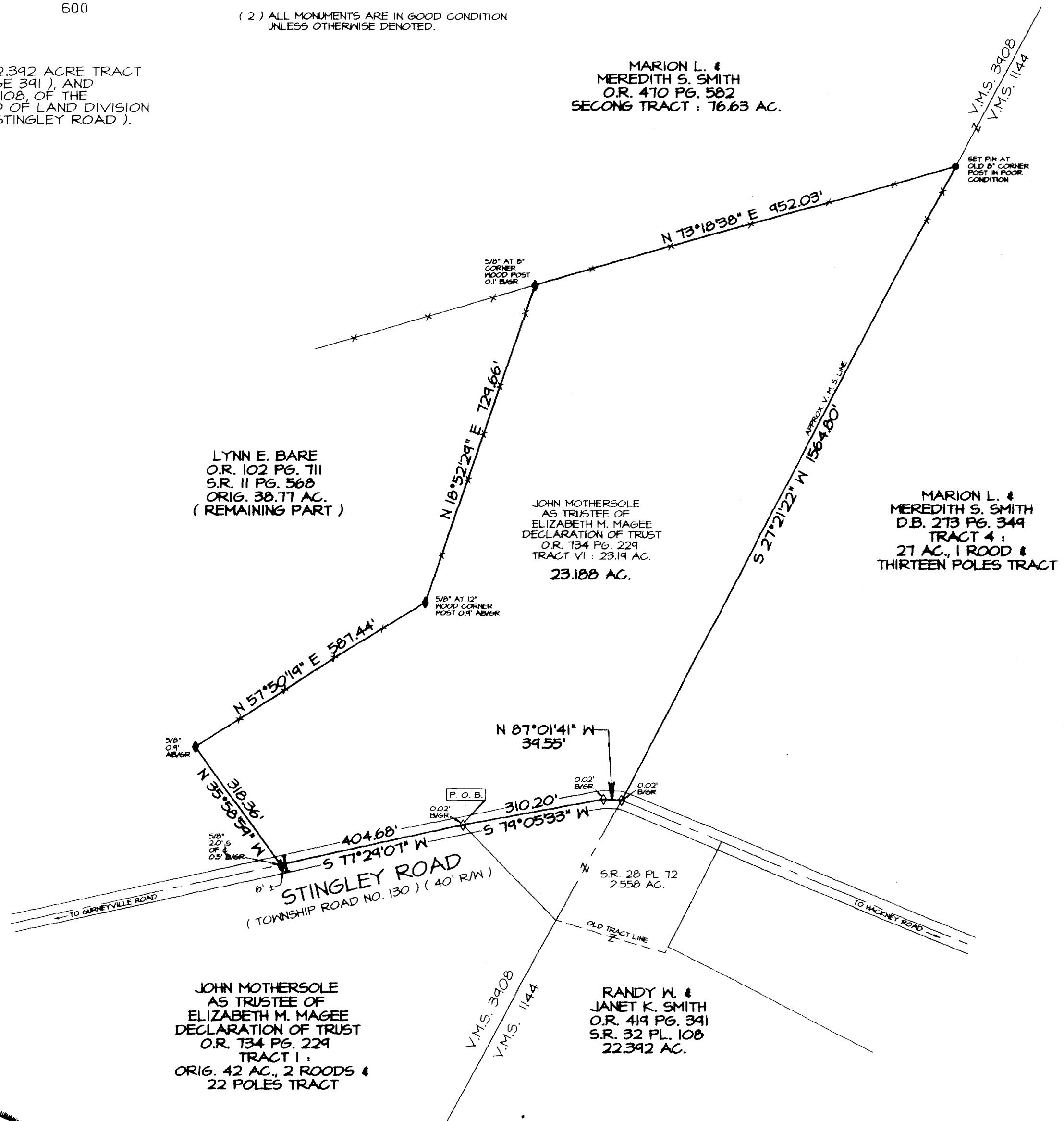


**BEARING REFERENCE**
